The Court has received and reviewed Plaintiffs' Status Conference Statement filed on 12/06/2023.

The Court and counsel confer in reference to the following:

#### **Remaining Parties-**

The parties clarify that the landowners Bolthouse, Grimmway, and Diamond are still in the action. It is the Leaseholders who are no longer in the suit. The landowners will be fully participating in the litigation.

#### Intervenor-

Cuyama Basin Groundwater Sustainability Agency has intervened as a Defendant as a matter of right. They do not intend to participate in this first phase of trial except to file a trial brief. Although the recent GSP uses Bulletin 118 as the basin's boundaries, Intervenor has not yet decided what position will take in this trial concerning the basin boundaries. The court orders that Intervenor's trial brief, if any, be filed no later than 5 court days before trial. Intervenor confirmed that at this point, it takes no position concerning the allocation of water from the basin as among the parties and understands that the Court will be undertaking such allocation at a later phase of the trial.

#### <u>Trial-</u>

All previously lodged binders, witness and exhibit lists remain unchanged. The parties may work with staff to bring in extra binders and to perform technology set up. Each side has one hour for opening statements.

Multiple defendants (those **disputing** Bulletin 118 boundaries) will first give opening statements and allocate the time among themselves.

Multiple Plaintiffs (those **supporting** Bulletin 118 boundaries) next will give opening statements and allocate the time among themselves.

At the conclusion of each trial day, the court will discuss with the parties the witnesses who will testify the following day, and the testimony estimates.

#### Disputes-

The parties dispute whether an expert, not being called to testify by the designating party, may be called at trial by the non-designating party. See CCP section 2034.310(A). The parties should meet and confer on this issue. If the issue cannot be resolved, each party may file a 5-page brief with the Court **prior** to trial.

The parties advise that they have exchanged demonstrative/slides before opening statements. As there are objections, the parties agree to meet and confer in reference to objections. The opening statement demonstratives appear to be limited to approximately 30 slides per opening statement.

The parties also advise that there may be 300 slides to be presented in connection with expert testimony. The Court expresses concern as to the number of slides, the parties advise that most concern introductory and educational materials on hydrology (the parties describe it as "Hydrology 101"). The Court appreciates the educational materials but cautions the parties to eliminate cumulative material and not to repeat the information.

The Objections and briefing is limited to 15 pages each and must be filed by 12/18/2023. A stand-alone [proposed] order must also be filed concurrently which provides a space for the Court to make its rulings [sustained / overruled] and a space for comments / further explanation.
