The Court has received and reviewed the parties' [proposed] Phase I Statements of Decision on Basin Boundaries, reports, and the [proposed] Case Management Order.

The Court and counsel discuss the following issues:

## 1. Statement of Decision

The parties argue the [proposed] Phase 1 Statements of Decision on Basin Boundaries.

The parties agree that the Department of Water Resources GIS "shapefile" for the Bulletin 118 boundary of Basin 3 - 013, a more detailed electronic map, must be added to Joint Trial Exhibit 1.

By <u>02/09/2024</u>, all counsel must:

A. Lodge a [proposed] Order re: Shapefile (that GSA will post the current version - as of the date of this order - of the shapefile of the Cuyama Valley Groundwater Basin, Basin No. 3-103, as mapped in Bulletin 118 on the GSA website. Such posting provides the public, all parties and the court with access to the shapefile);

B. Lodge a thumb drive with the shapefile (which the Court will maintain in its records); and

C. Email their previously filed respective [Proposed] Statements of Decision in Word format to the court at sscdept9@lacourt.org

If the ordered items are **NOT** lodged/emailed by said date subsequently an Order to Show Cause Re: Sanctions hearing will be set.

Groundwater Basin on 08/17/2021, and filed their First-Amended Complaint on 03/08/2022. The complaint seeks a comprehensive adjudication solely of groundwater rights to the Basin, and not an adjudication of any party's surface water right.

The Court issues an Order to Show Cause why this groundwater rights adjudication should not proceed solely with a groundwater rights determination, and **not** proceed with a determination of any parties' surface water right. The adjudication proceedings must continue without an adjudication of a party's surface water right until such time, if ever, such a determination is necessary under Code of Civil Procedure Section 833(c).

The Court sets an Order to Show Cause hearing. An Order to Show Cause Re: Surface Rights is scheduled for 03/11/2024 at 10:00 AM in Department 9 at Spring Street Courthouse.

If a party intends to claim a surface water right, the party **must** appear at the Order to Show Cause hearing. The appearing party must be prepared to tell the Court the location of well(s), if any, and any filings with the State Water Board, if any.

## 3. Sanctions Motion Hearing

Plaintiff's counsel may refile a Sanctions Motion Re: failure to file initial disclosures. Counsel must call the Court to obtain a hearing date and briefing schedule to refiling the motion.

## 4. Stipulation and [Proposed] Order Re: Meet and Confer Process

The parties state that they are experiencing difficulty meeting and conferring. Due to the problems, case management conference productivity and efficiency are reduced and case management conferences are unnecessarily lengthy.

To assist the parties in crafting a [proposed] Case Management Order (addressing a trial date, future motions, discovery, etc.), the Court orders counsel for Defendant Highland Vineyard SB, LLC, et al. to meet and confer with Plaintiffs' counsel and file and serve a Stipulation and [Proposed] Order Re: Meet and Confer Process by <u>03/01/2024</u>.

If the Stipulation and [proposed] Order is **NOT** submitted by said date subsequently an Order to Show Cause Rc: Sanctions hearing will be set.
