## [PROPOSED] PHASE 1 ORDER RE: LODGING DWR BULLETIN 118 CUYAMA BASIN BOUNDARY AND POSTING ON CUYAMA GSA WEBSITE

Following the January 26, 2024, hearing on the Statement of Decision and Case Management Conference, the Court directed counsel to (1) lodge a USB flash drive with the Court containing the current Cuyama Valley Groundwater Basin, Basin 3-013 ("Cuyama Basin") Bulletin 118 boundary shapefile and (2) prepare an order directing the Cuyama Groundwater Sustainability Agency ("Cuyama GSA") to post the shapefile to its website.

## NOW THEREFORE, IT IS HEREBY ORDERED:

- 1. The Court acknowledges receipt of the USB drive lodged with the Court by Defendants Highland Vineyard SB LLC, Brodiaea, Inc., and Albano Family LP et al., which contains the current DWR Cuyama Basin shapefile and shall be added to Joint Trial Exhibit 1 and shall be maintained by the Court in its record.
- 2. The Court orders Defendants Highland Vineyard SB LLC, Brodiaea, Inc., and Albano Family LP et al., to provide a copy of the DWR Cuyama Basin shapefile to the Cuyama GSA.
- 3. The Court orders the Cuyama GSA to post no later than 15 days from the entry of this order, and continue to host, the shape file on its website located at www.cuyamabasin.org while this matter is pending before this Court so the public and all parties to the case can access the shapefile.
